


2019 Annual Report

MEMBERSHIP

2019 was a banner year for membership! After over 15 years of steady unit decline, the NCCS experienced a **positive increase** in BSA Scouts units, although the total number of scouts continued to decline. Comparing troops gained (408) versus lost (386), we ended 2019 with PLUS 22 units! The majority of these new units were female troops chartered by Catholic Churches and Schools. (Note: There was a difference in total unit numbers between BSA and NCCS due to several Catholic units being counted as "community' units.) As part of the 2019 NCCS membership initiative, all the 408 new Catholic units will receive a special red FOUNDER'S streamer for their troop's flag.

The Membership Committee added 4 new members in 2019, representing Regions 1, 10, 13 & 14. Our goal is to have at least one representative from each Region participating on the committee. The Quality Membership Recognition Program (2018-2020) continued with qualifying Dioceses to be determined after the 2019 applications and data is received. The program's final award year will be 2020. Qualifying Diocese committees will receive these unique QD Gold and Silver lapel pins.



Membership initiatives for the future is to build upon the increased unit success. Correspondence to the Regions will encourage further contact with Catholic churches with schools on the possibility of starting Packs and Troops. Although we experienced an increase in units, we must work harder to reach out to Dioceses and parishes to increase the number of scouts participating in those units. A big part of this will be a "Best Practices" talking paper being developed for distribution. The membership committee will continue to be an NCCS accessible resource for our nationwide Dioceses.

e-Learning Courses. In 2019, NCCS released the first of a series of e-Learning courses. The first course offered was the Chartering Organizational Representative (COR) for Catholic institutions. Patterned after the BSA's COR training, NCCS' training provides four modules to help Catholic institutions better use the programs of the BSA as Catholic youth ministry. In development are Leader Specific e-Learning courses that will supplement the BSA's leader specific training. Direct contact leaders will become familiar with the concepts of Catholic youth ministry and how better to integrate the BSA's Scouting programs into a Catholic institution's youth ministry model.

National Catholic Leadership Development. In 2014, we changed the name of the Scouter Development: Lay Apostolate Formation for Scouting program to National Catholic Leadership Development. As one of our Basic courses, we felt the older name still wasn't attracting Scouters to participate in, or deliver, the course. The content still focuses on individuals being to consider how they are being called as Catholic Scouters to live their faith.

Regional Training. One of the primary responsibilities of the Region Chairs is to conduct a regional meeting whereby diocesan Scouting leaders can share best practices and lessons learned and discuss issues with their peers from other dioceses. With the need to promote participation in

membership development, religious emblems and religious activity programs, and training, Region Chairs have been more strongly encouraged to organize such events. Due to a lack of knowledgeable trainers, a day of training is conducted in conjunction with our annual Executive Board meetings. Every other year, the Training Committee coordinates the preparation of a set of workshops at the Biennial Conferences.

Local Training. As a part of the annual meeting, in 2019 we developed a workshop program to be conducted on Saturday morning for local Diocesan staff, Youth Ministers, Council Staff and Council/District who are unfamiliar with the BSA or NCCS. The program has two parts- first an overview of the BSA program for individuals who have not been involved in Scouting and second an overview of the NCCS programs for individuals who have not dealt with Catholic Scouting. The morning session would culminate with a box lunch cracker barrel to answer any of their questions. They would be offered the options to attend scheduled workshops in the afternoon, focusing on more detail like the Religious Medal programs and religious activities. The intent was to allow them to attend for free on Saturday so they wouldn't miss work or have any out of pocket costs other than their transportation. In the morning we would be using rooms that we have for afternoon workshops and the afternoon session would be part of the overall workshop program. We felt this would be a great opportunity to expose more local youth leaders to the NCCS and showcase our annual meeting utilizing the knowledge of our members for little cost other than the box lunches. Hopefully we will be able to have the inaugural session at next year's meeting.

Scouting in the Catholic Church Conference. Since its inception in 1974, the focus of this annual training conference has been the formation and training of leaders for diocesan Catholic Scouting committees. The 2019 Scouting in the Catholic Church conference was held at Philmont Training Center (PTC) from June 16-22. Faculty consisted of John Anthony as Course Director, Fr. Eric Groner as Course Advisor, Ronda Moti, Jim Weiskircher. Attending were 16 individuals that included one bishop and one priest, representing 15 dioceses. The NCCS offers scholarships to cover the cost of registration for those in financial need.

Scouting in the Local Church - Diocesan Committee Development Conference. The inaugural course was offered in February 2017 at BSA's Florida National High Adventure Sea Base Training Conference Center. The 2019 Scouting in the Local Church - Diocesan Committee Development conference was held at the Florida Sea Base on March 5-9, 2019. Faculty consisted of Kathy Polowski as Course Director, Fr. Ross Chamberland as Course Advisor, Fr. Kevin Smith, Joe Bouley, Connie Canter, Chris Murray, and Elizabeth Olivas. Attending were 22 individuals that included 2 priests. representing 15 dioceses. The NCCS offers scholarships to cover the cost of registration for those in financial need.

Jerusalem Cross. Those who participate in the Scouting in the Catholic Church conference may earn the Jerusalem Cross to add to the four beads received during the course. To earn the Jerusalem Cross, one must complete a "mission" utilizing the knowledge gained from the course. Recipients are recognized at the NCCS Annual Meeting. INTERNATIONAL

Over 35,000 young people had a great time at the 24th World Scout Jamboree at the Summit Bechtel Reserve in West Virginia July 22 through August 1. Former NCCS National Chaplain Father Mike Hanifin served as the lead Catholic chaplain and NCCS International Committee Chair Phil Krajec served as the coordinator of the International Catholic Conference of Scouting booth and other Catholic activities at the Jamboree.

The ICCS booth at the Jamboree was funded by NCCS and was staffed by volunteers from Italy, United States (Ynes Ortega, Chris Murray and Jim Cordek), Lebanon, and New Zealand.

The Faiths & Belief area at the Summit included a large tent with stalls for displays and activities by most of the world's major religious groups: Catholic, Islam, Hindu, Protestant, Buddhist, Sikh, Judaism and the Church of Jesus Christ of Latter-Day Saints. An estimated 13,000 people visited the booth over the course of the Jamboree. Visitors to the Catholic booth were welcomed with an opportunity to view the daily readings, play bells symbolizing the good news to be spread around the world, lash together a hand-made crucifix as a sign of meeting our Lord who died on the cross for us, and tie a rosary bracelet signifying the building of a relationship with God through prayer. Scouts were then invited to demonstrate that we are a community that meets in the name of God by sharing their thoughts on a wall poster. All visitors were given a pin with the ICCS Jamboree logo for them to easily remember the experience.

On Sunday, approximately 3500 worshipers attended a large outdoor Mass at which Apostolic Nuncio Archbishop Christophe Pierre served as principal celebrant and homilist. Concelebrants included current and former Bishop Liaisons to NCCS Daniel Conlon and Bob Guglielmone; Bishop of the Diocese of the Military Richard Spencer; ICCS World Chaplain Father Jacques Gagey; Fathers Kevin Smith, Gerard Gentleman and Mike Hanifin; and 38 other priests from eight different countries. Reverend Rick Tuggle served as the Archbishop's Deacon. Seven local seminarians acted as altar servers and Extraordinary Ministers of Holy Communion. Local musicians provided the music for the Mass. The readings and prayers of the faithful were led in French, Spanish and English by Scouts from Canada, Mexico and the United States, the three cohost countries of the Jamboree. A reception for over 100 clergy, dignitaries and volunteers followed the Mass.

In addition to the camp-wide Mass, Catholic chaplains celebrated daily masses in various locations throughout the Summit. Special camp-wide masses in Italian and Portuguese were also offered. The Franco-German Friendship Celebration, a World Scout Jamboree tradition since the end of the Second World War, was led by Father Benoit Vandeputte. Approximately 350 attended the event in the F&B area. Taizé services led by ICCS volunteers were offered several times throughout the Jamboree.

ICCS was blessed to have the generous support of the NCCS, local volunteers with the financial capacity to advance costs and the ability to transport materials to the Summit. Local parishes and the Diocese of Wheeling-Charleston were a great help, providing the altar, ambo, equipment, hosts and wine for the Sunday and daily masses.

RELIGIOUS EMBLEMS

The new Pope Pius XII is working successfully as an on-line only order item. Many old Pope Pius XII books are still in Scout Shops, so many classes are still being held using outdated materials. The Emblems Committee is undertaking a review of all materials to be sure that language reflects the new reality of female Cubs and Scouts. Emblem sales, as reported by

ESCO, turned up in 2019 but still show a general downward trend over time. 2014 data is included in the chart in order to extend the time period of comparison.

Analysis

Data provided by ESCO indicates that emblem sales increased significantly between 2018 and 2019 for both Cub Scout and Boy Scout emblems. The increases between the two years were relatively uniform across each emblem as shown below:

Boy Scouts:

Ad Altare Dei: 2017—3,215; 2018—1,715; 2019—1,937

Pope Pius XII: 2017—1,458; 2018—645; 2019—848

Cub Scouts:

Light of Christ: 2017—5,746; 2018—2,904; 2019—3,316

Parvuli Dei: 2017—7,888; 2018—3,568; 2019—3,889

One may assume that the increase in sales is due to a flattening out of the curve after the 2017 spike in sales caused by ESCO's price increase.

VOCATIONS

This committee was reestablished in 2019 after a hiatus. This committee as a stand-alone committee without consultation from other committees may isolate this committee's work from others which also promote vocations. Religious Emblems and Saint George Trek are two committees which have programs that are dedicated to assisting Scouts in exploring a possible vocation to religious life and priesthood. The Religious Activities committee has numerous plans that allow Scouts to examine the vocations of various saints. These three most certainly need a liaison with the vocations committee so each can inform the others about their works and successes, as well as share ways we can support each other.

Furthermore, the Chaplains committee and the Training committee play an important role in vocational discernment and promotion as they help in the formation of unit chaplains and chaplain's aides. Both of these committees can liaise with us to create a Catholic supplement to the BSA's training programs for chaplains and chaplain's aides. One role that we see in this supplement is how these two positions collaborate to ensure Catholic Scouts and leaders fulfill the Sunday obligation when camping.

EMMETT J DOERR MEMORIAL SCOUT SCHOLARSHIP \$20,000 in Scholarships Awarded in 2019

The National Catholic Committee on Scouting® established the Emmett J. Doerr Memorial Scout Scholarship to be awarded to seven outstanding Catholic high school seniors who are Scouts in a BSA program and continuing their education in college. To be eligible to apply the applicant must have earned the Ad Altare Dei, Pope Pius XII, or Light is Life Religious Award. In addition, they must have earned the Eagle Scout, Summit Award or Quartermaster Award. The scholarships are merit-based awards given to scouts for their outstanding service to their church, community, school, and Scouting. Since its inception in 2005, 74 Scouts have been awarded the Emmett J Doerr Memorial Scout Scholarship for a total of \$134,000.

In 2019, a total of \$20,000.00 was awarded through seven scholarships. This represents an increase in both the number of scholarships and amounts offered. The top award is \$5,000 first-place scholarship. Additional scholarships include \$4,000 for second place, \$3,000 for third, and four additional \$2,000 scholarships. This represents a 67% increase over 2018 award amounts. Additional scholarships are being made available due to the generous support of the Doerr Scholarship endowment and continued annual charitable giving.

Highlights

• Changes in Revenues

- Overall revenues were up \$17,048 (excluding realized investment gains) or 4.3% over 2018. This includes investment income of \$72,039 from the Morgan Stanley endowment and investment accounts.
- o 2019 Contributions were up \$11,135 or 13% over 2018
- Products sales and fees changed little.

• Changes in Expenditures

- o Overall expenditures were up \$19,567
- Cost of Goods sold was the primary factor in increased expenditures with an increase of \$39,496.
- NCCS provided the International Catholic Committee on Scouting (ICCS)
 \$23,024 in support for the World Jamboree.

• Changes in Fund Accounts

- While the Boy Scouts of America (BSA) will continue to manage our 4810 operating account for BSA related expenditures, NCCS now provides its own cash management needs through our Morgan Stanley (MS) holding account. The Executive Committee directed this change due to the potential impact of BSA's financial restructuring on NCCS' day to day operations. Morgan Stanley continues to manage NCCS's nine NCCS endowment and investment fund accounts.
- o NCCS overall funds were up \$630,479 or 16.3%.
- The Emmett and Martha Doerr Charitable Trust reaffirmed its commitment to the NCCS Scholarship program, with annual contributions of \$10,000 for current year scholarships and \$15,000 per year towards Scholarship endowment.

• Vendor Management

- Omega Printing Incorporated of Bensenville, Illinois, produces NCCS-produced booklets, maintains appropriate inventory levels, and provides order fulfillment. Booklets for religious activities and emblems are sold to BSA supply, Pray and other organizations.
- O Nicholson Printing, formerly Bluegrass Business Forms, Inc., has been maintaining inventory and providing Religious Activities order fulfillment for NCCS. NCCS reimburses Nicholson for shipping and pays a small fee to cover insurance and packing materials. Over 40 different items are stocked. As of December 31, 2019, Bluegrass held \$31,710 in inventory (at cost).
- Erffmeyer & Son Co. Inc. (ESCO), based in Milwaukee, Wisconsin, produces our religious emblems. NCCS owns the dies. Esco handles order fulfillment through their website pays NCCS royalties quarterly on emblems sold.
- NCCS adopted a new system for member management in late 2019. DonorPerfect is now used for meeting registration, membership registration, and donations.
 This provides NCCS greater flexibility for member information, and makes us less dependent on BSA for system changes and development.
- Income Tax Status: The NCCS is considered by the IRS subsidiary to the United States Conference of Catholic Bishops (USCCB) and, thereby, is allowed to assume the 501(c)(3) tax status of that organization (see IRS Group Ruling at http://www.usccb.org/about/generalcounsel/group-tax-exemption.cfm). The NCCS is listed in the Official Catholic Directory published by P.J. Kennedy & Sons. Additionally, because the NCCS maintains an operating account with the Boy Scouts of America (BSA), BSA has its own 501(c)(3) status, and BSA processes NCCS financial transactions, any donation made in the name of the National Catholic Committee (NCCS) or the Boy Scouts of America intended for the NCCS, may be considered a tax-deductible contribution.
